A Bidder desirous of taking part in e-tender/quotation invited by The Chairperson, Haldibari Municipality will login to the e Procurement portal of the Government of West Bengal from the website: http://wbtenders.gov.in directly with the help of their Digital Signature Certificate.

- **B.**He will select the tender to bid and initiate payment of pre- defined EMD/Tender fees for that tender by selecting from either of the following payment modes:

5) SPECIAL TERMS & CONDITIONS AND SPECIFICATION OF WORKS:

- ** In order to ensure Sustainability to the created assets, particularly to the roads within the Municipal Areas, The Defect Liability during the period of 3 years is being incorporated.
