A Bidder desirous of taking part in e-tender/quotation invited by The Chairperson, Haldibari Municipality will login to the e Procurement portal of the Government of West Bengal from the website: http://wbtenders.gov.in directly with the help of their Digital Signature Certificate.

B.He will select the tender to bid and initiate payment of pre- defined EMD/Tender fees for that tender by selecting from either of the following payment modes:

- (i) Net Banking (any of the listed bank in the ICICI Bank payment Gateway) in case of payment through ICICI Bank Payment Gateway
- (ii) RTGS/NEFT is case of offline payment through bank account in any bank.

Payment Procedure:

5) SPECIAL TERMS & CONDITIONS AND SPECIFICATION OF WORKS:

- ** In order to ensure Sustainability to the created assets, particularly to the roads within the Municipal Areas, The Defect Liability during the period of 3 years is being incorporated.
- ** The Security Period for the Security Deposit/EMD is 1 year.
 - a) The tenderer should quote his base offer as per the quantity described in the Schedule, which may be accepted by the department if found technically acceptable and economically viable.

Opening & evaluation of tender:

Opening of Technical Proposal:

Technical proposals will be opened by the Concerned Tender Inviting Authority or his authorized representative electronically from the website using their Digital Signature Certificate (DSC).

Intending Tenderers may remain present if they so desire.
